### **Founding Spirit**

While Dr. Shigeyoshi Matsumae, the founder of TES, was young, he tried to find a path along which he should direct his future life. He asked himself the question, "How should I live my life to maximize my energy, faith and devotion?" Attending a Bible Study Group conducted by Kanzo Uchimura, a Japanese teacher of Christianity, he found himself particularly impressed by Uchimura's thoughts. In particular, the history of Denmark, and the rebuilding of that nation through education, were particular sources of enlightenment for him. Eventually, he opened the Bosei-gakujuku school and devoted his life to education. This was the start of today's Tokai University Educational System.

The founder, Dr. Matsumae adopted a four-passage slogan for the Bosei-gakujuku school students as follows:

Cultivate your thoughts in your early days Nurture your body in your early days Develop your intellect in your early days Aim your hopes towards the stars in your early days

These slogans remind us that we should cultivate both our bodies and our minds to the fullest possible extent. If an individual has acquired deep insights into human nature, society, the natural world, historical processes, the world, and so on, he or she will be able to embrace high ideals and can lay the foundation for a deeper understanding of life. TES continues with these ideals of building a balanced, civilized society, educating today's youth to continue in the spirit of our founder, and carrying on the mission of writing tomorrow's history with a spirit of a pure humanitarian mind.

### 4. Examination Admission Slip

## **5** Application Qualifications

### 1. Master's Program

Those who meet both the following category 1) and 2).

- 1) Those who are or will be sponsored by a foreign government or Japanese government (the Ministry of Education, Culture, Sports, Science and Technology (MEXT) Scholarship) or those who are nominated by an institution which has an Academic Exchange Agreement with Tokai University. Also, those who are nominated by an institution which has an Academic Exchange Agreement with Tokai University are required to have at least a 2.8 GPA in principal.
- 2) Those who meet one of the following requirements (1)-(3) as stipulated in article 102 of the School Education Act, and who also satisfy both (4) and (5).
  - (1) Those who graduated or will graduate from a university or college, as defined in Article 83 of the School Education Act by September 2023 (Autumn semester enrollment)/March 2024 (Spring semester enrollment).
  - (2) As stipulated in Article 155 of the School Education Act Enforcement Regulations, those who are recognized by Tokai University to have academic abilities equivalent to those of university or college graduates and meet any of the following:
    - ①Those who completed or are expected to complete a bachelor's degree by September 2023 (Autumn semester enrollment)/ March 2024 (Spring semester enrollment) according to the stipulations in Article 104, Item 4 of the School Education Act.
    - <sup>(2)</sup>Those who completed or are expected to complete 16 years of formal school education outside Japan by September 2023 (Autumn semester enrollment)/March 2024 (Spring semester enrollment).
    - ③Those who completed or are expected to complete 16 years of formal school education of a foreign country by September 2023 (Autumn semester enrollment)/March 2024 (Spring semester enrollment) by studying subjects in Japan via a correspondence course offered by a school in that country.
    - (4) Those who completed or are expected to complete a course of a foreign educational institution in Japan by September 2023 (Autumn semester enrollment)/March 2024 (Spring semester enrollment) (the graduate must be considered to have completed 16 years of formal school education in the foreign country), which is qualified to offer university courses in the foreign country's educational system, and is specifically designated by the Minister of Education, Culture, Sports, Science and Technology.
    - (5) Those who have been awarded a degree equivalent to a bachelor's degree through completion of a course at a foreign university or other foreign school in which the term of study is three years or more (the study and research must be acknowledged by the foreign government or must be designated by the Ministry of Education, Culture, Sports, Science and Technology), and those who are expected to be awarded degrees by September 2023 (Autumn semester enrollment)/ March 2024 (Spring semester enrollment). This includes completion of online courses of foreign universities while in Japan or taking courses in educational facilities of foreign universities located in Japan.
    - (Those who completed or are expected to complete by September 2023 (Autumn semester enrollment)/March 2024 (Spring semester enrollment) a specialized course at a vocational school (the minimum course length must be four years or longer and the course must satisfy all other regulations designated by the Minister of Education, Culture, Sports, Science and Technology) specifically designated by the Minister of Education, Culture, Sports, Science and Technology, and which satisfies other conditions specified by the Minister.
    - ⑦Those designated by the Minister of Education, Culture, Sports, Science and Technology (Official Announcement 5 issued by MEXT in 1953).
    - <sup>®</sup>Those who enrolled in another graduate school as stipulated in Article 102, Item 2 of the School Education Act, and who are recognized to have academic standards adequate to Tokai University Graduate School.
    - (9) Those who are deemed by a separate application qualification screening to have academic abilities equivalent to those of university or college graduates and who have reached 22 years old (those born on or before October 1, 2000 (Autumn semester enrollment)/April 1, 2001 (Spring semester enrollment)).
  - (3) As stipulated in Article 156 of the School Education Act Enforcement Regulations those who are recognized to have academic standards equivalent to those who have a Master's degree or a degree specified by the Minister of Education, Culture, Sports, Science and Technology in Article 104, Item 1 of the School Education Act.
  - (4) Those who have a Japanese ability equivalent to Japanese Language Proficiency Test (JLPT) Level 2 (N2) and have an English ability equivalent to CEFR B1. In the case of those that cannot speak English, Japanese ability should be equivalent to JLPT Level 1 (N1). In the case of those that cannot speak Japanese, English ability should be the equivalent to CEFR B2. However, regarding acceptance into the graduate school, in the case that there are no language issues upon acceptance the above requirements do not apply.
  - (5) Those who can enter Japan on or before the designated date that will be notified after the announcement of acceptance.

### 2. Doctoral Program

Those who meet both the following category 1) and 2).

- 1) Those who are or will be sponsored by a foreign government or Japanese government (the Ministry of Education, Culture, Sports, Science and Technology (MEXT) Scholarship) or those who are nominated by an institution which has an Academic Exchange Agreement with Tokai University.
- 2) Those who meet one of the following requirements (1)-(3) as stipulated in the proviso of paragraph (1) of Article 102 of the School Education Act, and who also satisfy both (4) and (5).
  - (1) Those who completed or are expected to complete a Master's degree by September 2023 (Autumn semester enrollment)/ March 2024 (Spring semester enrollment).
  - (2) Those who completed or are expected to complete a professional degree by September 2023 (Autumn semester enrollment)/March 2024 (Spring semester enrollment).
  - (3) As stipulated in Article 156 of the School Education Act Enforcement Regulations those who are recognized to have academic standards equivalent to those who have a Master's degree or a professional degree and satisfy one of the conditions listed below.
    - ①Those residing in a foreign country and completed a Master's degree or a professional degree or are expected to complete an equivalent degree by September 2023 (Autumn semester enrollment)/March 2024 (Spring semester enrollment).
    - <sup>(2)</sup>Those who have taken overseas graduate programs via a correspondence course while in Japan and received or are expected to receive a degree equivalent to a Master's degree or a professional degree by September 2023 (Autumn semester enrollment)/March 2024 (Spring semester enrollment).
    - ③Those who completed or are expected to complete a course of a foreign educational institution in Japan and received a degree equivalent to a Master's degree or a professional degree by September 2023 (Autumn semester enrollment)/ March 2024 (Spring semester enrollment), which is qualified to offer university graduate courses in the foreign country's educational system, and is specifically designated by the Minister of Education, Culture, Sports, Science and Technology.
    - (4) Those who completed a course at the United Nations University which was established as stipulated in the Act on Special Measures Incidental to Enforcement of the Agreement between the United Nations and Japan regarding the Headquarters of the United Nations University based on the approval by the UN General Assembly on December 11, 1972 and obtained a Master's degree or an equivalent degree.
    - (5) Those who completed a course at an overseas school, an educational institution specified in the above (3), or the United Nations University and passed an examination and a review specified in the Article 16-2 of the Standards for the Establishment of the Graduate Schools and are recognized to have academic standards equivalent to those who have a Master's degree.
    - <sup>©</sup>Those designated by the Minister of Education, Culture, Sports, Science and Technology (Official Announcement 118 issued by MEXT in 1989).
    - Those who are deemed by a separate application qualification screening to have academic abilities equivalent to those of a Master's degree or a professional degree holder and who have reached 24 years old (those born on or before October 1, 1999 (Autumn semester enrollment)/April 1, 2000 (Spring semester enrollment)).
  - (4) Those who have a Japanese proficiency equivalent to Japanese Language Proficiency Test (JLPT) Level 2 (N2) and have an English proficiency equivalent to CEFR B1. In the case of those that cannot speak English, Japanese ability should be equivalent to JLPT Level 1 (N1). In the case of those that cannot speak Japanese, English proficiency should be the equivalent to the CEFR B2. The tuition and fees should be paid as a lump sum.

### 3. Refund of Tuition and Fees

In principal, refunds of paid tuition and fees will not be issued. Only if an applicant expresses his/her intention of withdrawal from enrollment for specific reasons and completes the procedures for withdrawal [detailed procedures can be found in the registration guide] by Fall semester enrollment: August 31 (Thursday), 2023/Spring semester enrollment: 4:00 pm (strict deadline) on March 30 (Saturday), 2024, [documents must arrive or have been submitted by this time] will tuition and other fees, with the exception of the admission fee, be refunded (For details, please refer the registration guide after you receive an announcement that you have been accepted).

Once the payment of tuition and fees is made, admission fee will not be returned for any reason.

### 4. Other cautions

- (1) If you change your current address after applying, please contact Tokai University Global Initiatives.
- (2) If registration procedures are not completed by the due date, enrollment will not be permitted.
- (3) We will not ask you by telephone to transfer the tuition and fees.
- (4) For applicants who applied with a certificate of expected graduation / completion, enrollment permission will be rescinded if qualifications to enroll in graduate school are not obtained by the End of September 2023 (Autumn semester enrollment)/End of March 2024 (Spring semester enrollment).
- (5) If false or incorrect information is found on application or registration documents, admission will be cancelled even after enrollment.

### 5. Documents Required after Registration

- (1) Those who applied for admission and registered for enrollment with the certificates of expected graduation (completion) or / and expected degree (master's) conferral document must submit a certificate of graduation (completion) or a certificate of degree when receiving student ID card.
- In the case of the above-mentioned certificates are not submitted or the requirements for application / admission are not satisfied (2)after the registration for enrollment, the acceptance for admission shall be canceled.
- To those who registered for enrollment into the Master's program: Those who registered for enrollment into the Master's program (3) with academic credits form graduate programs of Tokai University or other universities in hand can apply for credits transfer at the time of admission. Be ready to submit the academic transcript. If the program was completed at another university, you will also be required to submit the syllabus.
- To those who registered for enrollment into the Doctoral program (except for enrollment into the Graduate School of Science and (4) Technology and Graduate School of Bioscience): Those who have completed the Master's program and registered for enrollment into the Doctoral program can apply for credits transfer at the time of admission. Be ready to submit the academic transcript. If the program was completed at another university, you will also be required to submit the syllabus.

  - 2) Successful applicants of the Doctoral Program: Admission fee is waived for graduates (Master's programs) of Tokai University, Kyushu Tokai University and Hokkaido Tokai University. For those who graduated from the undergraduate school of Tokai University, Kyushu Tokai University or Hokkaido Tokai University who then completed a graduate program in another university, admission fee is also waived.

## 8 Privacy Policy

Personal information collected by Tokai University during the admissions process will be used as follows:

## **9** Security Export Control

Tokai University has established the Tokai University Rules on Security Export Control in accordance with the Foreign Exchange and Foreign Trade Act, and conducts strict examinations for acceptance of students, etc. Please note that international applicants who fall under any of the conditions set out in said regulations may not be able to enroll in their desired course or program.
